# **Emergency Assistance to Nonpublic Schools (EANS) Program**

As part of the Coronavirus Response and Relief Supplemental Appropriations Act, 2021, (CRRSA Act) Public Law 116-260, Congress set aside \$2.75 billion of the Governor's Emergency Education Relief (GEER) Fund specifically to provide emergency assistance to students and teachers in nonpublic schools through the Emergency Assistance to Nonpublic Schools (EANS) program.

The purpose of the EANS program is to provide services or assistance to eligible non-public schools to address the impact that the Coronavirus Disease 2019 (COVID-19) has had, and continues to have, on non-public school students and teachers in the state.

On February 5th, 2021, Governor DeWine submitted a signed certification and agreement for Ohio's EANS award. Ohio received an EANS award of **\$154,896,274**. The Ohio Department of Education (ODE) is responsible for the administration of the EANS program.

## **Preparation for EANS Services and Assistance**

In March, eligible nonpublic schools applied to receive services and assistance through the Emergency Assistance to Nonpublic Schools (EANS) program. Details of this process can be found in CCIP Note 466.

In May, the Ohio Department of Education released EANS Service Amounts for nonpublic schools that completed an EANS application. Details of this process can be found in <a href="#">CCIP Note 469</a>.

The Ohio Department of Education contracted with Education Service Centers (ESCs) across Ohio to provide EANS services and assistance to nonpublic schools that received an EANS Final Service Amount.

EANS Final Service Amounts have been updated to adjust for changes to eligible nonpublic schools and EANS administrative costs. The EANS Final Service Amounts for each nonpublic school and listing of the ESC providing services can be found <a href="here">here</a>.

#### **EANS Services and Assistance**

In early July, Education Service Centers will consult with the nonpublic schools for which they are contracted to provide EANS services and assistance. The Ohio Department of Education has provided the nonpublic school EANS applications to contracted ESCs. Nonpublic schools may request changes to the EANS services listed on the EANS application. Through consultation, the ESC will determine the means, method, manner, and process of delivering EANS services and assistance.

Nonpublic schools may request *reimbursement* through the ESC for certain expenses they incurred or will incur that are allowable in the EANS program. A nonpublic school may be reimbursed only for expenses from the list below that the school incurred on or after March 13, 2020, to prevent, prepare for, and respond to COVID-19, that have not already been reimbursed with Federal funds, including PPP. Reimbursable expenses include:

- Supplies to sanitize, disinfect, and clean school facilities
- Personal Protective Equipment (PPE)



- Physical barriers to facilitate social distancing
- Other materials, supplies or equipment recommended by the CDC for reopening and operation of school facilities to effectively maintain health and safety
- Expanding capacity to administer coronavirus testing to effectively monitor and suppress the virus
- Educational technology
- Leasing sites or spaces to ensure social distancing
- Reasonable transportation costs

Some EANS services and assistance <u>are not</u> reimbursable. These EANS services and assistance must instead be provided by the ESC or supplemental provider. EANS services and assistance that are allowable but may not be reimbursed include:

- Improvements to ventilation systems (including windows), except for portable air purification systems, which may be reimbursed.
- Staff training and professional development on sanitization, the use of PPE, and minimizing the spread of COVID-19.
- Developing instructional plans, including curriculum development, for remote or hybrid learning or to address learning loss.
- Initiating and maintaining education and support services or assistance for remote or hybrid learning or to address learning loss.
- Any expenses reimbursed through a loan guaranteed under the PPP (15 U.S.C. 636(a)) prior to December 27, 2020.

The ESC will ultimately be responsible for determining the method, manner, and process for providing EANS services and assistance on behalf of the Department.

The ESC will provide EANS services and assistance up to the EANS Final Service Amount for each nonpublic school for which it has been contracted to provide services by September 30, 2023. The services rendered will not exceed the EANS final service amount for the school.

# **EANS Timeline**

- EANS Final Service Amounts were provided on April 1, 2021, and updated to adjust for changes to eligible nonpublic schools and EANS administrative costs on June 18, 2021.
- ESCs will begin consulting with nonpublic schools and providing EANS services and assistance on July 1, 2021.
- Nonpublic schools may request and receive EANS services and assistance through the ESCs from July
  1, 2021 throughout the EANS period of availability until September 30, 2023.
